

This MOU is non-binding and does not impose any legal or financial obligations or liabilities on either party.

This Memorandum of Understanding shall remain in effect for 3 years with effect from 31st December 2021 unless either party terminates sooner by notifying the other party in writing or the joint activities contemplated by this letter are completed before the end of the 3 years period. The parties may extend this MOU beyond three years by mutual agreement.

Each party shall designate a person or office to serve as liaison officer for implementing this Memorandum of Understanding. For JJM Healthcare Solution, Chennai, the contact person will be The CEO, Dr. Murali Mani. For SVDC Dr. Jeelani will be the contact person.
